2010 CALL FOR ENTRIES FOR OPEN EXHIBITION

Photomedia Center calls for artists to submit work for inclusion in its annual juried show. It is open to all artists internationally working in any photographic media—including collage, digital, traditional and alternative processes, and new media—and there is no restriction on subject matter. Selected works will be exhibited online at Photomedia Center, photomediacycenter.org, during the month of September 2010.

One work will be selected for the Purchase Award, which will be added to Photomedia Center's permanent print collection. One artist from the show will be selected for a solo featured show at Photomedia Center during its 2011 season. Accepted works may be offered for sale by the artists during the show. The 2010 Open Exhibition will be archived on Photomedia Center and continuously available for viewing online in the past exhibitions of the site after the show concludes.

GUIDELINES

Artists may submit up to 10 pieces by CD or email (no slides or prints) for consideration. **All submissions must be accompanied by a completed application form or it will not be processed for review by the juror.**

For email submissions: Attach a scan (pdf preferred) of the completed application form along with images and submit payment via paypal, indicating payment email address. **All email submissions must be sent to: info@photomediacycenter.org with the subject line *Open Show Entry* and your last name.**

For CD submissions via postal mail: Include a printout of the completed application with CD of images and submit payment by either check, money order, or paypal. **All postal entries should be sent to: Photomedia Center, P.O. Box 8518, Erie, PA 16505, USA.**

Entry fee is \$5 per image; early entry is \$3 per image if entry is received by June 15, 2010. **Entry fees are waived entirely for current Photomedia Center members.**

Acceptable file formats are either JPEG or TIFF only. Please label images clearly with the work's title corresponding to the application list clearly referencing image titles by number. Files must be no larger than 800 pixels on the image's longest side at 72 ppi. If submitting by post, label the CD with your name.

All artists will be notified via email no later than August 29, 2010, so make sure your application includes a valid email address. If you wish the return of your CD, you must supply a self addressed, stamped envelope with proper return postage. Otherwise all submissions materials will be recycled at the end of the process.
